

PVPV/RAWLINGS ACE PAYMENT SCHEDULE – 2019-2020

According to Florida State Law all Extended Day fees must be collected in advance of care. There are 180 days of school and 180 days of Extended Day Care. This is divided into 10 equal payments covering 18 days in each payment cycle.

IMPORTANT: PLEASE READ ALL INFORMATION CAREFULLY. OUR RATES HAVE CHANGED AND ARE STILL AWAITING SCHOOL BOARD APPROVAL.

REGISTRATION IS NON-REFUNDABLE. PAYMENTS are non-refundable unless approved by the Coordinator under special circumstances.

REGISTRATION PAYMENTS MADE BY JUNE 1ST ARE \$75 AFTER JUNE 1ST THE FEE IS \$100. This is per child. If you make your first payment with your early registration fee you will only have one payment in August, otherwise you will have two payments in August – by the 6th and again on the 15th. All payments are due on the 10th of the month with the exception of August (Payment 1 due Aug. 6th, Payment 2 due Aug. 15th)

STUDENTS NOT REGISTERED BY AUGUST 6TH, WILL NOT BE ABLE TO ATTEND ACE UNTIL AUGUST 19TH and there will be NO Pro-Rating.

PRICING: To better align with District r, our fees have been raised \$50 for AM care only, \$25 for PM only and \$25 for AM/PM. The sibling discount has been reduced from 50% to 40%. Students currently enrolled in ACE this year who reregister for next year will be grandfathered the 50% discount rate.

PAYMENTS: Pay by CASH, CHECK OR SCHOOLPAY (schoolpay.com). You can also set up month payments through your banks online checking. Be sure all payments reach us by the 10th of the month and include **CHILD'S NAME AND A PHONE NUMBER.**

LATE PAYMENT AND LATE PICK-UP CHARGES WILL BE STRICTLY ENFORCED!!! Late Payment Fee is \$25 if payment not received by 15th of month. Late Pick-Up (after 6:00 p.m.) is \$1 per minute. If your payment is late and you are past the covered service date your child will not be allowed to attend ACE. After 3 late payments your child may be suspended from the program. If you have extenuating circumstances please talk with the Coordinator and we will try to work with you.
