## 5. New Business: Dr. Crummie (October District Parent Focus Group)

Main topics of discussion - accreditation, legislation, and strategic plans (Superintendent Forson)

- St. Johns County School District Strategic Plan 2023-2028

- Implement a guaranteed and sustainable framework for communication (staff surveys, focus group interviews, SAC survey data).
- Provide support to hire, retain, and coach teachers and staff (student progress, climate surveys, HR retention data, staff attendance, etc.).
- Provide students with expectations, guidance, resources, and opportunities to develop their voice (define student voice, framework of measures with out-comes, interest inventories, etc.).
- Implement personalized learning and student supports (master schedule, staff, and student surveys, MTSS data =, etc.).
- Technology (classroom observations, curriculum maps, staff professional learning, and staff and student surveys).
- The district must review all software prior to releasing it to schools
- All software programs are reviewed with the current curriculum in mind.
- Parents are notified regarding the use of the product once all approvals are rendered.
- A major dilemma with approving software is ensuring the companies are not sharing or using student data.
- Main concern is student data privacy
- (5) K-8 schools are underway
- Sheriff is open to all forms of communication (discussed recent events at Creekside High School).
- Highest need in the district (ESE teachers) and (Specialized area in High Schools). Retention of teachers (more than half of the teachers have less than 5 years of experience).
