According to Florida State Law all Extended Day fees must be collected in advance of care. There are 180 days of school and 180 days of Extended Day Care. This is divided into 10 equal payments covering 18 days in each payment cycle. IT IS IMPORTANT WE HAVE YOUR CORRECT PHONE \# AND EMAIL ADDRESS AS ALL COMMUNICATION IS DONE VIA SCHOOL MESSENGER.

BE AWARE THAT PAYMENT \#2 IS DUE ON AUGUST 15TH. AFTER PAYMENT \#2 ALL PAYMENTS ARE DUE ON THE $10{ }^{\text {Th }}$ OF THE MONTH, STARTING WITH PAYMENT \#3 DUE SEPTEMBER 10TH.

REGISTRATION BY MAY $24^{\text {TH }}$ IS $\mathbf{\$ 1 2 5}$ AFTER MAY $24^{\text {TH }}$ THE FEE IS $\mathbf{\$ 1 5 0}$ PER CHILD. PAYMENT \#1 IS DUE BY AUGUST 1ST. REGISTRATION IS NON-REFUNDABLE. PAYMENTS are non-refundable unless approved by the Coordinator under special circumstances. There are no mid- payment cycle refunds.

PAYMENTS: Pay by SCHOOLPAY (schoolpay.com), CHECK (include Phone Number) or CASH. You can also set up monthly payments through your bank's online checking. Be sure all payments reach us by the $10^{\text {th }}$ of the month and include CHILD'S NAME AND A PHONE NUMBER.

LATE PAYMENT AND LATE PICK-UP CHARGES WILL BE STRICTLY ENFORCED!!! Late Payment Fee is $\mathbf{\$ 2 5}$ for the first occurrence if payment not received by $15^{\text {th }}$ of month.
